- Road work on Surrey Road
 - East of Hoover- Estimate to clear trees and stumps.
 - Dated March 7, 2024 - Clare Road Commission contacted Bill about fixing the road. First request is \$191,590 (our cost \$95,795). Potentially two phase project: Phase one estimate \$99,272 (our cost \$49,636), Phase two estimate \$92,318 (our cost \$46,159).
 - Board recommends we need to focus on Rogers, start at the County line and go North. Motion to contact the Road Commission and see how far \$50,000 can go with ditching and grubbing, made by Bill and supported by Jen. Motion carried.
