The meeting was called to order at 7:00 PM.

Pledge of Allegiance recited.

PRESENT: Bill Strouse, Supervisor; Jennifer Magnus, Treasurer; Raquel Brown, Clerk; Brian Tomaski, Trustee; Jim Eberhart, Trustee; Renee Merrihew, Deputy Clerk. 10 Residents.

BOARD MEETING:

Minutes and budget from last month's meeting were shared with the board. Motion by Jennifer to approve minutes and supported by Jim. Motion carried.

TREASURER'S REPORT: Treasurer's report stands as read.

TOWNSHIP BILLS: The township bills were shared with the Board. Motion by Raquel to pay the bills and supported by Brian. Motion carried.

CLERK'S REPORT:

TRUSTEES' REPORT: Tomaski mentioned trees in Thompson Cemetery, three are dead - the estimate to take care of them \$1,700. Motion made by Bill to have trees cleaned up at Thompson for \$1,700, Jennifer supported. Motion carried.
